

## **Baghlan OCT/IDPs Coordination Meeting**

**Date: 28.3.2017**

**Venue: ACTED PIK office meeting room**

Opening remarks have done by ACTED Emergency Response Field Coordinator and welcomed all the participants to the meeting.

### **Response to Pul-e-Khumri verified IDP families:**

Based on discussion with meeting participants it is agreed that food item will be distributed by WFP, ACTED will distribute cash for NFIs and DACAAR will distribute hygiene kits to 193 IDP families which recently verified through joint assessment teams in Pul-e-Khumri city and distribution will take place on Thursday 30 Mar 2017 in NPO PIK Office. Assessment report and beneficiaries list will be shared with relevant stakeholders once ACTED finalized it.

### **Response to Baghlan-e-Jadid district verified IDP families:**

As per the meeting discussion it is decided that ACTED will distribute cash for food and NFIs to Baghlan-e-Jadid verified families due to following problems:

1. WFP will not be able to conduct distribution in Baghlan-e-Jadid district due to security concerns and problems that will be expected through local armed groups and those people who have not received assistance yet,
2. If WFP invite the beneficiaries to Pul-e-Khumri distribution point, in this case beneficiaries will face with some problems of carrying the big package of food item from PIK to Baghlan-e Jadid district,
3. In case if they can transport their food item from PIK to Baghlan Jadid district affected villages, they will need to undertake some transportation cost for received assistance and it will be against of humanitarian assistance policy.

Based on abovementioned reasons and challenges it decided that WFP should not distribute food items to Baghlan-I-Jadid IDPs, instead ACTED will distribute cash for food and NFIs and each family will receive around 20,000 AFN.

**Distribution Points:** the joint distribution will take place in NPO PIK Warehouse to 193 verified IDP families, but distribution to Baghlan-e-Jadid district verified IDP families will take place in ACTED PIK Office where several distributions have conducted before.

### **Screening of new collected Petitions:**

After screening of 535-petitions on 06 Mar 2017, Baghlan DoRR has received about 1417 more new petitions from Dand-e-Ghuri areas conflict IDPs that have been screened as below:

- **1417 petitions have been screened**
- **1349 petitions to be assessed**
- **68 petitions have been rejected**

The mentioned 68-petitions rejected due to no conflict in their displaced villages and for the time being their current locations are inaccessible for joint assessment teams.

Total 1349-petitions divided within three teams to start their assessment ASAP and rejected petitions submitted back to DoRR.
