### Shelter Working Group Coordination meeting 22 November 2017

**17:00 pm, Ministry of Housing (Roseau opposite financial center 1<sup>st</sup> floor)**

#### 1. Introduction

Present: **UNDP**, DRCS / IFRC, Shelterbox, IsraAid, Samaritans Purse, IOM, ITNAC (Is There Not a Cause), All Hands, UNICEF (Wash), Dominica Charity Foundation.

Excused: Ministry of Housing was excused for this meeting but available by telephone

#### 2. Assessments

##### Ministry of Housing / UNDP

- Ministry of Housing Damage assessment is ongoing. Currently approximately 11,500 houses assessed. **At this stage** (about 40% of the data) the division of damage is given in the table and compared with the PDC extrapolated data from aerial imagery from Copernicus, which is currently used as the basis for the shelter response:

- The first preliminary conclusion is that there are less severely damaged houses than estimated before in favor of more houses with limited damage. Which is a positive indication for the planned response.
- The high number of completely destroyed houses seems to be rather consistent.

##### Caritas / CRS:

- Caritas is conducting a household assessment. Currently they assessed more than 1,000 households in the South East of Dominica. Area's involved are house damage, wash, and economic situation.
- The assessment (summary) will be share as soon as it is available.

##### DRCS / IFRC

- A few assessments are conducted focusing on different type of interventions ie (unconditional) Cash support, NFI support and shelter repairs.
- The assessment (summary) are usually published on their website.

##### IOM

- IOM started the 3<sup>rd</sup> round of DTM, visiting all the collective centers. In addition a spot check survey on the situation in host families is planned. Will be published through the usual channels.
- The construction teams are assessing the damage of the houses of vulnerable families as part of the ongoing repair works.
- IOM support the vulnerability assessment of the Ministry of Social services with data entry capacity.



Samaritans Purse

- Household assessments are ongoing in preparation of the house emergency repair program

IsraAID:

- IsraAID assesses houses around collective centers, with the purpose to support voluntary relocation of the people in the collective centers. In a tailored approach the people are supported with NFI's or instant house repairs.

**3. NFI / shelter Distributions**

- Update of reported distributions will be share next meeting, because the information manager just arrived. Please update, when not already done!
- Shelterbox has 255 tents in the region which could be a suitable solution for people in collective centers or provision of more privacy in / around host families. The government has sofar not endorsed bringing in these tents. Shelterbox will explore the opportunities to bring them in the coming days, otherwise the shipment will be cancelled and the tents put in contingency stock.

**4. Verification of the planned area's for shelter / house repair and transitional solutions**

- Most organizations have given more or less detailed indication of the geographical area they intend to work in
- UNDP will base their plans on the ongoing house damage assessment. The plan will be developed in collaboration with the government.
- It is not clear where the government is planning to erect the announced Pre-fab houses. For the humanitarian agencies this information is required to determine the need and place for transitional shelter and tent solutions.
  - AP: The coordinator will address this location and planning of prefabs with the ministry of housing

**5. Procurement & import duties**

- All organizations are in the process of asking for quotations for construction materials with suppliers in and outside Dominica.
- The procurement expert of IOM arrives in country on the 24<sup>th</sup> of November and will also lead the combined procurement initiative.
- The Shelter WFG coordination team has produced in collaboration with the ministry of finance a guidance note on the waiver of import duties for construction materials, announced by the Government of Dominica.

- Samaritans Purse, Caritas / CRS and IOM are all working on a design for a transitional shelter solutions, to bridge the gap between current displacement / totally destroyed house and a durable housing solution.

- UNDP asked for a similar approach for permanent housing solutions.
